

## Snapshot of ORICL for NQS Exceeding Themes

Participating in the ORICL Project and engaging with the ORICL tool provides evidence for NQS Exceeding Themes in the following Standards and Elements:

Standard 1.1 – Program: The educational program enhances each child's learning and development.

**1.1.2. Practice is informed by critical reflection.** The service's approach to curriculum decision-making is informed by current recognised research evidence.

Standard 1.2 – Practice: Educators facilitate and extend each child's learning and development.

**1.2.1. Practice is embedded in service operations.** Educators are consistently deliberate, purposeful and thoughtful in all of their decisions and actions that impact on children's learning, development and wellbeing.

**1.2.2.** Practice is informed by critical reflection. The service's educational practice approach to facilitating and extending children's learning, development and wellbeing is informed by current recognised research evidence.

Standard 1.3 – Assessment and planning. Educators and co-ordinators take a planned and reflective approach to implementing the program for each child.

**1.3.1. Practice is embedded in service operations.** The educators at the service consistently engage in evidence-based research that supports critical reflection on children's learning, development and wellbeing and the perspectives of the child, their child's peers and the educators' response.

**1.3.2.** Practice is informed by critical reflection. The service's approach to assessment and planning is informed by current recognised research evidence.

Standard 7.2 – Leadership: Effective leadership builds and promotes a positive organisational culture and professional learning community.

**7.2.1. Practice is embedded in service operations.** Effective leadership is embedded in everyday practice to build educator capacity by supporting educators, through ongoing professional development opportunities, practitioner inquiry and collaborative research projects, such as...
