# What's new since the last newsletter?

#### New Item Reference Guides (and what are they?)

'Item reference guides' are a printable version of all of the ORICL items/questions (including the colour coding for the child, the child's peers, and the educator) that can be handy to use in the room when it isn't convenient to log into the digital tool. The guides can also support other educators in your room to collaborate and provide additional feedback or insights into the child's learning.

In response to educator feedback, we are pleased to announce a new 'series' of Item Reference Guides. In case you haven't taken a peek, we now have versions with space to write your notes or observations. These are available in *Member Only Resources* when logged into your account and can be printed out by a single domain or as one document including all domains.

#### HOT OFF THE PRESS: ORICL mapped to NQS Exceeding themes

We are pleased to announce the release of a document that maps your participation in the ORICL Project to the Standards and Elements for NQS Exceeding themes. Standards and Elements relevant to the ORICL project are listed and sample text is provided for Standard 1.1.2. To complement this document and support the A&R process, we also have an 'Item Reference Guide' (printable ORICL questions) that lists *only* the Educator ORICL items – perfect for self-reflection or discussion points at a staff meeting.

The 'Snapshot of ORICL for NQS Exceeding Themes' and 'ORICL Tool ITEM Reference Guide: Educator Aspect' can be found in the Member Only Resources. Don't forget that you can also print a Child Summary with only the Educator aspect when you have filled in ratings and/or observations (see page 22 of the User Guide).



#### Child Summaries with photos are now available

Described in our December newsletter, the feature of generating a Child Summary is now available. You can do this at any time – you don't have to wait to finish and submit the tool. The summary will include all comments/observations you have entered, and you can now choose whether or not to include your uploaded photos in the summary. More information and a step-by-step guide can be found on page 21 of the latest User Guide V2.2 (attached) and available in the *Member Only Resources* when logged into your account.

Educators, please note that the summaries are for educators use as a professional practice tool and to help start and support conversations with families and other educators. They were not intended to be shared with the child's parents.

### **Response to ORICL survey and Certificate of Appreciation**

When you have finished entering ratings and observations into the ORICL tool, don't forget to hit the 'SUBMIT' button on the final page of the tool. We will then send you a link to a quick survey where you can tell us about your experience using the ORICL tool: Please be honest as your feedback is critical for us to learn about what is working and what could be improved to refine the ORICL tool. When you have completed the survey, you will receive a Certificate of Appreciation that you can use for your professional portfolio - perfect for A&R and as evidence of your involvement and contribution to a large research project! A little tip: To hasten delivery of your certificate please ensure you go all the way to the end and click submit so that we receive the notification (even if you write N/A for some questions!).

#### Speaking of certificates...

We also have a Certificate of Participation for centres/FDC services. This is a certificate you can place on a noticeboard to advertise your involvement with the ORICL project to families and visitors (and of course as evidence of participation for A&R). Periodically we run a report, and certificates are sent based on educator's engagement with the tool (i.e., they had added a child or two and have begun adding ratings). If you've missed receiving your certificate, please contact Tracy.
